The Town and Country Planning Act 1990
and the Acquisition of Land Act 1981

The Town and Country Planning Act 1990 section 226 (1) (a)

The North Norfolk District Council (in this order called "the acquiring authority") makes the following order—

1. Subject to the provisions of this order, the acquiring authority is under section 226 (1)(a) of the Town and Country Planning Act 1990 hereby authorised to purchase compulsorily the land described in paragraph 2 for the purpose of facilitating the carrying out of development, redevelopment or improvement to contribute to the promotion or improvement of the economic, social and environmental well-being of the acquiring authority's area.
2. The land authorised to be purchased compulsorily under this order is the land described in the Schedule and delineated and shown edged red and coloured pink on a map prepared in duplicate, sealed with the common seal of the acquiring authority and marked "Map referred to in the North Norfolk District Council (No 1, 1 High Street, Sheringham, NR26 8JP) Compulsory Purchase Order 2020".



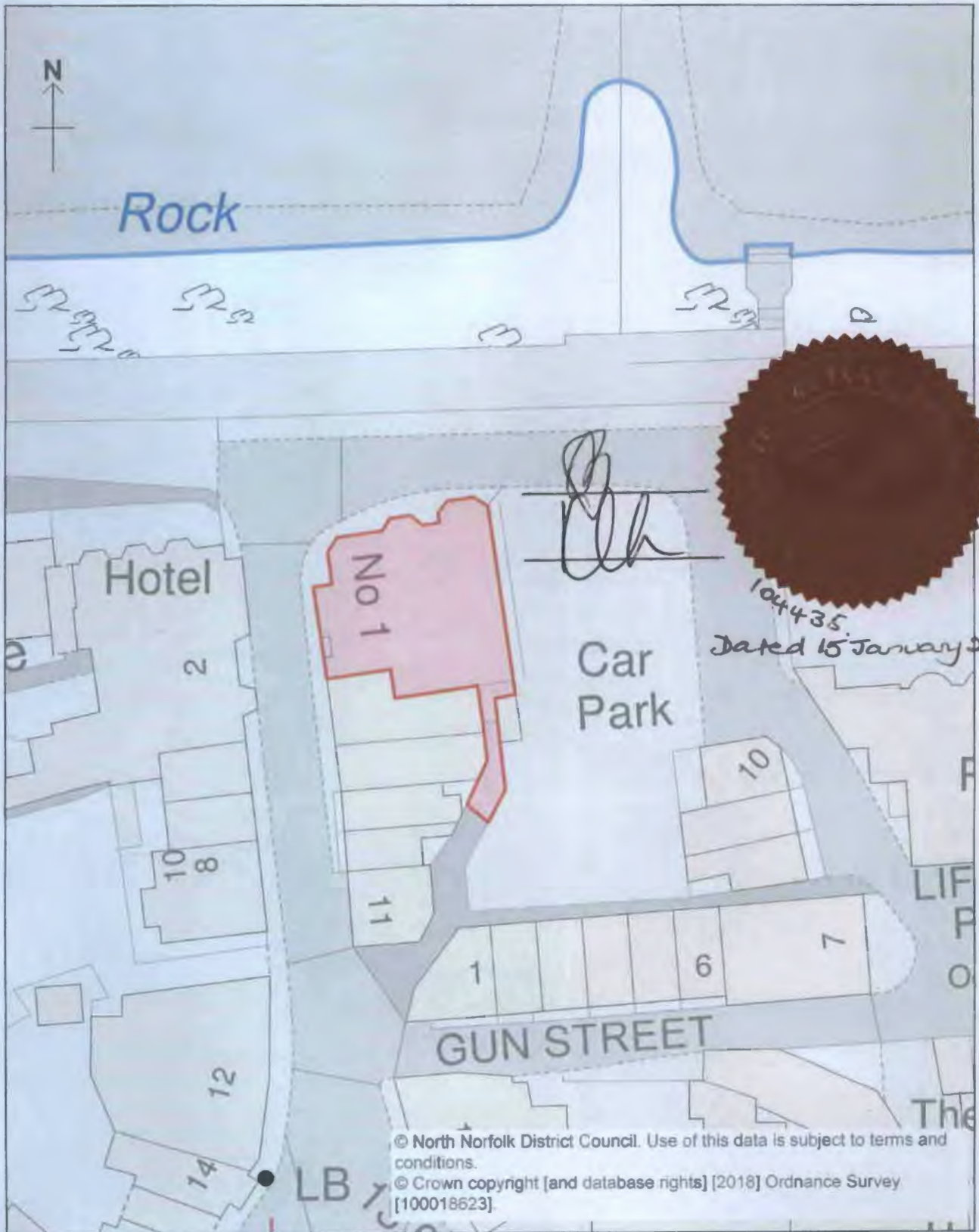

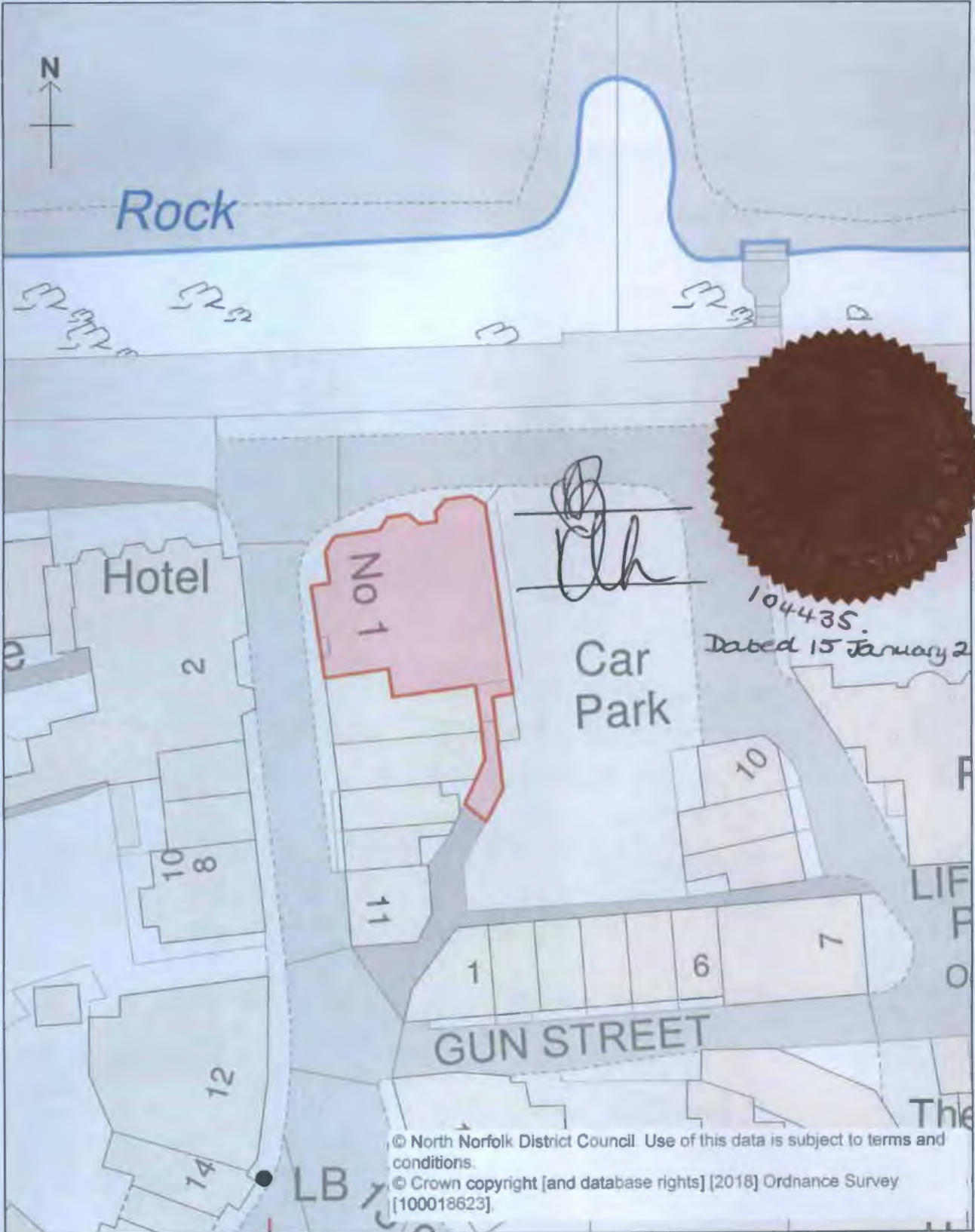
