A message from the Leader

Welcome to this edition of the North Norfolk District Council Outlook magazine. At this time, NNDC and all of Norfolk's councils are working towards the submission of proposals for the reorganisation of local government.

The Government wishes to see the existing District and County Councils in England replaced with fewer unitary councils. What this will likely mean is there will be as few as one, and as many as three, new local authorities across Norfolk, providing services such as social care, highways, collection of waste and recycling, planning and housing.

We, alongside the majority or Norfolk's councils, support three unitary councils across Norfolk to achieve the best possible levels of representation over a large rural area for our villages, coastal and market towns.

We certainly have concerns about representation over such a significant geography, and to what extent our communities will have a voice among larger communities across Norfolk.

Whilst we recognise the potential for a unitary council for Greater Norwich, which is currently constrained with much of the business and housing development occurring outside of the 1970's boundaries – which in turn is affecting decision-making and limiting growth - we do not currently see the same opportunity for the rest of rural and coastal Norfolk.

We are also deeply concerned about the future funding and provision of our discretionary assets and services, which include important facilities such as Cromer Pier, our swimming pools, open spaces, including locations such as Holt Country Park, and public toilets, which are all important to our communities and the North Norfolk economy.

To use the QR codes, simply use the camera on a smartphone to scan the QR code. We are now working to try and secure the future of these for the longer term, with a variety of different plans and outcomes likely to emerge.

We have also raised the question of the future of coastal protection management responsibilities and adaptation where our work has continually been of national significance, although the Government's Devolution White Paper made no mention of this vital service provided by coastal authorities.

Besides this, the most significant change in local government in over 50 years, life goes on and council services must continue as normal. We are also continuing to progress many projects such as the Mundesley Coastal Scheme, and we are delighted to showcase those recently completed including another modern and inclusive public toilet facility at Albert Street in Holt, the Cromer Pier Pavillion Theatre Dressing Rooms - and the return of our blue flag beaches all detailed in this edition.

As you can see, your councillors are working to achieve the best possible solution for our district via the local government reorganisation process - while ensuring our 'business as usual' activity continues to see high standards of delivery and support for our residents and other stakeholders.

It's a challenging balance but one I believe our councillors and officers have risen to. We will continue, as always, to put the needs of North Norfolk first in all that we do on your behalf.

Housing for the community, by the community

In Swanton Novers, a collective of residents formed a Community Land Trust to deliver local housing, for people with a connection to the village or immediate area.

The Swanton Novers Community Land Trust took guardianship of the land, donated by Lord Deleval Astley. Working with the Council and Broadland Housing Association, construction has begun to build seven new affordable homes. Community Led Housing is where local residents, working with the Council, landowners and developers, deliver affordable housing for local people and take a lead role in that process for their community.

The Council is very keen to work with more communities across North Norfolk to deliver housing in this way, creating genuinely affordable homes to meet housing need for local people.

Local homes to meet local need

Through our housing delivery partners, the Council continues to develop new affordable homes in North Norfolk to meet the local demand, for local people.

Broadland Housing Association are building 15 new affordable homes in West Beckham and Salthouse, which will be available this summer, and let to households with a local connection to the immediate area.



Through Medcentres and Housing 21, 61 new Extra Care affordable rented apartments will be available in Stalham.

These independent living homes for older residents are expected to be completed in Spring 2027, with 43 one-bed and 18 two-bed apartments available to residents aged 55 or over. The scheme is funded by Homes England, Norfolk County Council and North North District Council.

Through a special partnership, Flagship Housing and Homes for Wells delivered 12 new affordable homes in Warham.

Flagship Housing are also delivering 24 affordable houses on the West Wood development in Sheringham, and 23 new rented affordable homes in Walcott.

Construction has also begun this year on 47 properties in Bacton, with a mix of affordable rented and shared ownership, allowing local people to step onto the property ladder.

Flagship Housing are also proposing to build 26 new affordable homes in Ludham.



The Council is always keen to hear from landowners who may be able to help communities by offering up land for local homes - or private landlords to come forward to provide homes for local people in housing need.

They also have planning permission for 10 affordable homes in Little Snoring, which are for households with a local connection.





National Coastal Practitioners Conference comes to North Norfolk

Each year, the Environment Agency and Coastal Group Network host the Coastal Practitioners Conference. This year it was held in the Pavilion Theatre on the fantastic Cromer Pier in the sunshine, with visits to Happisburgh, Mundesley, Bacton and Trimingham.

The annual conference was attended by around 200 delegates from a range of organisations that have a role in managing the coast around the country, including coastal management teams from various councils, Environment Agency employees, and public sector organisations. The conference provides a valuable space to create and maintain professional networks, build skills and share learning.

This year, North Norfolk District Council shared learning from Coastwise about preparing for coastal erosion, presented examples of where we have improved sea defences at Bacton, Mundesley and Cromer, as well as early career development opportunities in coastal management.

Did you know that Coastwise is working with church authorities to better understand policy and legislation around graveyards that are at risk of being lost to erosion?

Investigations will inform the future of how graveyards continue to be used and how they can be sensitively managed when they face loss due to coastal erosion.

Did you know that the Norfolk Museums Service works with over 50,000 school children a year across East Anglia?

The Norfolk Museums Service is partnering with Coastwise to include learning about our eroding coast through the fossils, historic change and geology.

Did you know that there are no insurance policies that cover coastal erosion?

Coastwise is working with insurance experts and national policy makers to identify and explore if erosion could be covered by insurance.

Did you know that you can check the erosion risk in your community and local area?

Earlier this year the Environment Agency updated the erosion risk maps for the UK. It shows the erosion risk areas in North Norfolk and the rest of the UK, based upon historic erosion rates and climate change scenarios.

Cromer and Mundesley coastal schemes complete

Over 2024 and early 2025, major coastal engineering works were delivered in both Mundesley and Cromer, extending protection to over 600 homes and properties from coastal erosion.

The Cromer scheme was completed at the end of 2024 and we are delighted to confirm successful completion of its Mundesley counterpart.

21,000 tonnes of rock were dropped onto Mundesley beach and positioned to disperse the energy from the waves and protect the sea wall. This helps to prevent beach lowering and reduce the amount of beach pebbles that land on the promenade during storms.

In these locations, existing concrete sea walls were reinforced with new concrete encasement and sheet piles.

The works were popular, with many visitors marvelling at the 'dance' performed by diggers on the beach.

The two schemes received approximately £25 million of funding in total and were undertaken by contractor Balfour Beatty, who contributed over £400,000 to the local economy through employment, supply chain and supporting local initiatives. The two schemes have been recognised with national awards - the Considerate Contractors Bronze Award, the SCAPE Award, and the Back to Basics Award. Both schemes are currently being nominated for other national awards.





Cllr Harry Blathwayt, portfolio holder for Coast, said:

"These coastal schemes are a massive feat of civil engineering and a huge undertaking for a coastal authority.

The protections delivered here will support Cromer and Mundesley for years to come."

New plans for unused plot at North Lodge Park

Following public engagement, the Council will be applying for planning permission to build a car park on the unused concrete area at North Lodge Park. The car park will have 40 spaces, electric vehicle charging points, accessible parking and could generate up to £120,000 in income per year. The Council plans to ringfence up to £50,000 of this income annually, to re-invest back into the park, helping to support businesses in the east end of Cromer and secure the future of North Lodge Park for years to come.

New public toilets open in Albert Street, Holt

The old toilet block has been demolished and replaced with new facilities which are water efficient, energy efficient and accessible with a Changing Places facility, the seventh provided by the Council across its principal towns.

Daniel King, Assistant Director of Finance and Assets said:



"We're delighted to see the completion of the new toilet facilities at

the new toilet facilities at Albert Street, which mark a significant improvement for both residents and visitors to Holt.

"The new conveniences not only replace what was lost but provide a modern, accessible, and environmentally sustainable solution.

"This investment reflects our commitment to inclusive infrastructure and the continued enhancement of our town centres."

Curtain goes up on theatre improvements

Backstage at The Pavilion Theatre on Cromer Pier has undergone a full refurbishment, delivering much needed improvements.

The dressing rooms, kitchen and bathroom facilities and theatre staff offices had not been refurbished in over twenty years and needed significant repairs and investment.

The old cramped, cold and dilapidated dressing rooms have been replaced with roomier facilities, which are properly heated and insulated, and feature acoustic bi-fold doors, allowing the three rooms to open up into one or two larger rooms, or partially opened to maintain privacy and still allow performers to communicate with one another.

Each room is also synchronized to the stage through screens and speakers.







The introduction of a wheelchair accessible lift to the stage means that Cromer Pier can also accommodate performers with limited mobility, and an accessible changing room and shower room has been fitted next to the stage.

Homelessness has risen across North Norfolk and, as a result, this remains a major area of focus and expenditure for the Council.

While progress has been made expanding our services to meet growing needs, there's still more to be done. As part of the strategy review, we will consult residents, community groups, and partners to gather views and lived experiences. Your input will help shape our priorities for the next five years. Our experienced Community Connectors are now delivering targeted Community Outreach, with a renewed focus on:

- Preventing homelessness
- Promoting health and wellbeing
- Reducing health inequalities

Everyone deserves to live in a home that is safe, comfortable, and accessible.

Through Disabled Facilities Grants, residents with disabilities can maintain independence and dignity with essential home adaptations.

Last year, the Integrated Housing Adaptations Team (IHAT) supported over 220 households, delivering improvements such as accessible bathrooms, stairlifts, ramps, and kitchen modifications—allowing people to live safely and confidently in their own homes.

Emergency help when it's needed the most

The Household Support Fund offers crucial relief when it matters most, whether it's a broken boiler in winter or a sudden loss of income.

In total, over £175,000 has been distributed across 1,350 North Norfolk households, supporting with essential costs like food, energy and urgent home needs.

This Department of Work & Pensions fund has enabled residents in difficult or dangerous personal circumstances, such as domestic abuse, to rebuild their lives thanks to the vital support the fund provides.

Some residents, when forced to leave their home without any belongings, have been able to access essentials such as clothing and toiletries, enabling them to restore a sense of dignity and stability during an incredibly difficult time.

Cllr Wendy Fredericks, Portfolio Holder for Housing and People Services said:

"Funds like these enable residents to retain their



dignity and keep day-to-day essentials going when they have urgent home needs or crisis. It's important that we're able to support them during what can be a very distressing and difficult time."

Finding temporary accommodation solutions

Councils have a duty to assess the needs of those presenting at risk of homelessness. When permanent accommodation cannot be found, nightly paid accommodation must be used. This is very expensive and the costs cannot be fully reclaimed from the government - last year, temporary accomodation costed the Council over £750,000.

The Council is purchasing and refurbishing properties to reduce the reliance on nightly paid accomodation. We now have 29 temporary accomodation homes to support people and will continue to acquire more.

Throughout the year, Cllr. Holliday has been actively engaging with community dementia groups across the district to personally thank the volunteers who dedicate their time and energy to supporting individuals with dementia and their carers.

Alongside meeting volunteers, Cllr. Holliday held a Dementia Networking Event to bring together groups and organisations working in the dementia care sector within North Norfolk.

We would like to thank Cllr. Holliday for her service and contributions to her chosen charities and the dementia care sector in the district, raising £5,000 in total.

Development of Fakenham Leisure Centre to begin later this year

Planning permission has been granted for the development of Fakenham Leisure Centre, to extend the offering to include a 25-metre swimming pool and outdoor sports facilities.

The current facilities, owned by the District Council and operated by award-winning leisure partners Everyone Active, currently comprises of a sports hall, fitness suite, multi-use area, dance studio, changing rooms and reception area.

Construction of the new facilities is expected to begin before the end of 2025.

Fakenham Leisure Centre



is committed to enhancing accessibility in North Norfolk for individuals with physical and mental disabilities. The Trust's services eliminate barriers that prevent individuals, their families and carers from enjoying the coast and countryside.

The Trust owns and operates the North Norfolk Wheelyboat "Poppy", which provides wheelchair-accessible ferry boat trips.



Cllr Tim Adams, Leader of the Council, said:

"This is a significant milestone towards the provision of modern swimming and leisure facilities in the growing town of Fakenham, and we continue to be grateful for the support of the community and Fakenham Town Council that has got us this far. We look forward to beginning this development later in the year"

Working towards a new Local Plan

The Council continues to work towards adopting a new Local Plan.

The Local Plan will guide and manage development in our District and will replace a document that was agreed in 2008. To comply with Central Government requirements, it will set out where at least 557 homes per year can be provided from now through to 2040.

In April, our Government appointed Planning Inspector held a number of hearing sessions to discuss and examine our draft Plan.

Following the hearing sessions, they advised us that with 'suitable Main Modifications' it should be possible for our Plan to be adopted later this year. We are currently working to agree these modifications with the Planning Inspector and we will then consult on them for a six week period over the summer.

Following consultation the Council will send the comments received to the Inspector, who will then write to us setting out their 'final report' on our draft Local Plan.

We hope to be in a position where we can 'adopt' our new Plan by the end of 2025.

Communities creating a planning vision

There are now five completed Neighbourhood Plans in North Norfolk: Blakeney, Corpusty and Saxthorpe, Holt, Ryburgh and Wells-Next-the-Sea.

A Neighbourhood Plan allows a community to create a vision and planning policies for the use and development of land in a neighbourhood, such as where new homes and businesses can be built or how they look, taking into account local issues and perspectives. These work alongside the emerging Local Plan. The Neighbourhood Plan process is led by the relevant Town or Parish Council and 10 other councils have formally advised the District Council that they are working on their own Plans.

We have organised a training session on the Neighbourhood Planning process for Town and Parish Councils in September 2025.

Generate your own energy with a solar discount!

As energy prices continue to rise, many homeowners are looking to reduce their energy costs and carbon footprint.

Installing solar panels and storage batteries can be a great investment, helping you save on energy bills. On average, North Norfolk residents who install solar panels and batteries would save up to one tonne of carbon from being emitted every year and save £1,000 a year on their energy bills.

As part of our goal to assist North Norfolk in reducing district wide emissions, we've partnered with MakeMyHouseGreen, a trusted scheme that's helped many homeowners successfully transition to solar.

Under the Government's Smart Export Guarantee (SEG), you can get paid for any excess electricity your panels generate by selling it to the grid. Solar panels can also increase the value of your home by improving your EPC rating and offering energy savings to potential buyers.

To take the first step, talk to MakeMyHouseGreen to assess if solar is right for you, find out how much you'd save, and how much energy you could produce. There is no obligation to buy and you are encouraged to get quotes from other suppliers for comparison.

Eco-learning space

The Council has been successful in its application for a grant of £100,000 from Ørsted's Hornsea 3 Legacy Fund to use in Holt Country Park. The grant will help fund the development of a new indoor/ outdoor community eco-learning space, with energy efficient insulation, a sedum roof and rainwater harvesting.

This will include learning stations to teach and promote sustainability, environmental impact and renewable energy production.

Our amazing Muddy Boots volunteers regularly join us to assist the Rangers with woodland maintenance and conservation.

The sessions are a chance to learn new skills in a screen-free environment and meet new people in a relaxed atmosphere, across Holt Country Park, Pretty Corner Woods and Sadlers Wood.

Mundesley and Sea Palling regain Blue Flag status

Sheringham, West Runton, East Runton, Cromer, Mundesley and Sea Palling have all been awarded Blue Flag status for the 2025 season from the environmental charity Keep Britain Tidy.

Mundesley and Sea Palling have regained the award after losing their status in 2022.

Blue Flags and Seaside Awards are international awards, managed by Keep Britain Tidy.

To get either award, a beach must meet a certain set of criteria, including;

- Water guality and beach cleanliness the Environment Agency regularly test bathing water.
- Water safety the beaches are lifeguarded by the RNLI over the summer.
- Local amenities such as public transport and toilet provision.

Cllr Liz Withington, portfolio holder for Communities, Leisure and Outreach, said:

"Earning Blue Flag status" is a proud moment for our coastal towns.

It's a mark of excellence that tells visitors our beaches are not only beautiful, but also clean, safe, and sustainably managed."

Pitching in for a smart new playing surface

The project to deliver a new pitch for Cromer kicked off in March, after years of discussion to replace the old sand-based pitch.

North Norfolk's first 3G pitch, built to FIFA standards and located at Cromer Academy, will provide quality training and match facilities for local clubs to hire and will be utilized by the Academy during the school day.

It will be available to the community during evenings, weekends and school holidays alongside the other sports facilities on site, which include a sports hall and gym.

This project has been delivered between the Council, the Inspiration Trust, Norfolk Football Association and the Football Foundation, and will form part of the dual-use community sports centre offer at the site, operated on behalf of the Council by Everyone Active.

Time to recycle disposable vapes

The Government ban on single use or disposable vapes began on 1 June 2025. A disposable vape is classed as nonrechargeable or non-refillable and before the ban 1.3m were thrown away every week. Any disposable vapes must be disposed of safely at designated recycling points which are easily accessible across the district.

Disposable vapes contain a lithium battery, which is hard to separate from the single-use plastic casing which leaks harmful chemicals as it degrades.

Safely disposing of them at designated recycling points is essential. Vapes or lithium batteries in with your kerbside collection or street bins can cause fires.

This recently occurred on Serco's collection rounds, where a lithium battery was compressed inside the refuse vehicle, causing it to explode and set fire to the contents. Fortunately, the fire was detected early and the contents ejected, but Norfolk Fire & Rescue Service were still needed to extinguish the fire.

They can also cause fires or explosions at the disposal and treatment facilities. Vapes and Lithium batteries also impact recycling rates, both as contamination and if there is a fire in a load, the whole collection load must be

Postal Vote Renewal

Following the implementation of the Elections Act 2022 a postal voting arrangement cannot last longer than three years.

Postal voters who are required to reapply will have recently received an email or a letter inviting them to reapply, and are encouraged to respond to do so at the earliest opportunity.

The deadline to reapply is 31st January 2026 but we are inviting early responses as there are over 13,500 North Norfolk electors with postal vote arrangements that need to be renewed and we want to allow voters plenty of time to renew if they wish to do so.

All households are required to report any changes from the details shown on the letter received. However, you may not need to respond if the details are correct.

Please check your letter as it will clearly show if you are required to respond even if the elector details shown are correct.



Customer Services - Here to help

Since our last issue in November, our Customer Services team has assisted with over 37,000 customer enquiries, resolving over 73% of enquiries at the first point of contact.

Of those resolved, 93.7% of customers who completed our survey were satisfied with the helpfulness of the advisor and 91.6% were satisfied with the advice they were given. In the summer months, enquires can increase about anti-social behaviour, such as nuisance complaints, fly-tipping and dog fouling.

Submitting an enquiry can be done online 24/7 and ensures that all the relevant information is collected so that it can be progressed efficiently and in a timely manner. Over 70% of customer interactions with the Council are now completed online.
