

# **NNDC Social Media Competition Terms and Conditions**

### 1. The Promoter

The promoter is: North Norfolk District Council of Council Officers, Holt Road, Cromer, Norfolk NR27 9EN ('NNDC')

# 2. The competition

- 2.1 The title of the competition is Cromer Beach Chalet Competition.
- 2.2 Win the use of Chalet Cromer East 28 for up to one (1) week starting from 10am 27 August 2022 to be vacated by 3.30pm 2 September 2022.
- 2.3 The competition will be running across Facebook and Twitter and only 1 prize is available.

#### 3. How to enter

- The competition will run from 4pm on 29 June 2022 (the "Opening Date") to 4pm on 13 July 2022 (the "Closing Date") inclusive.
- 3.2 All competition entries must be received by NNDC by no later than the Closing Date. All competition entries received after the Closing Date are automatically disqualified.
- 3.3 To enter the competition, go to NNDC official Twitter or Facebook pages and Like the competition post. Only 1 entry per person.
- 3.4 No purchase necessary and there is no entry fee to enter this giveaway or competition.
- 3.5 NNDC will **not** accept responsibility for competition entries that are lost, mislaid, damaged, or delayed, regardless of cause, including, for example, because of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.
- 3.6 By submitting a competition entry, you are agreeing to be bound by these terms and conditions.
- 3.7 The winner will be chosen by random.

## 4. Eligibility

- 4.1 The competition is only open to all residents in the UK aged 18 years or over, **except**:
  - (a) employees of NNDC
  - (b) employees of agents or suppliers of NNDC who are professionally connected with the competition or its administration or
  - (c) members of the immediate families or households of (a) and (b) above.
- 4.2 In entering the competition, you confirm that you are eligible to do so and eligible to claim the prize. NNDC may require you to provide proof that you are eligible to enter the competition.
- 4.3 NNDC will not accept competition entries that are:
  - (a) automatically generated by computer
  - (b) completed by third parties or in bulk
  - (c) illegible, have been altered, reconstructed, forged, or tampered with

- 5.3 You will be responsible for ensuring that you and any person travelling with you are available to travel on the dates specified.

- 6.3 NNDC must either publish or make available information that indicates that a valid award took place. To comply with this obligation NNDC will send the surname and county of the prize winner to anyone who writes to the address set out in clause 1 (enclosing a self-addressed envelope) within one month after the Closing Date of the competition.
- 6.4 If you object to any or all your surname, county and winning entry being published or made available, please inform NNDC on acceptance of your prize. In such circumstances, NNDC must still provide the information and winning entry to the Advertising Standards Authority on request.
- 6.5 NNDC does not accept any responsibility if you are not able to take up the prize.
