Notice: The Council is inviting representations, on the North Norfolk Local Plan Proposed Submission Version between **Monday 17 January** and midnight **Monday 28 February 2022.**

Subject Matter: The Local Plan provides details on the scale and distribution of growth and detailed strategic planning policies, including preferred development sites, to help deliver and direct the growth needs of the District between the period 2016 and 2036.

Representations Period: Monday 17 January to midnight **Monday 28 February 2022.** Representations must be received by Monday 28 February 2022. Only representations received within the representations period have a statutory right to be considered by the Inspector at the Examination.

This final consultation stage is your chance to make representations on whether the document is legally compliant i.e has been prepared in accordance with the relevant legislation and whether it is 'sound' i.e. positively prepared, justified, effective and consistent with national policy.

Area Covered: The administrative area of the District of North Norfolk, except for those parts of the District in the designated Broads Authority Area.

Availability of Documents: The proposed submission documents, and all supporting documents, will be available via <u>www.north-norfolk.gov.uk/localplanconsultation</u> from Monday 17 January 2022. Paper copies will be available to view over the consultation period at public libraries in the District, and during normal office opening hours at NNDC Main Offices, Holt Road, Cromer, and Fakenham Connect, Oak Street, Fakenham.
