## THE NORFOLK COUNTY COUNCIL (RUNTON, VARIOUS ROADS) (STREET PARKING PLACES) AMENDMENT ORDER 2023

The Norfolk County Council propose to make an Order under the Road Traffic Regulation Act 1984, the effect of which would be to amend the Norfolk County Council (Runton) (Street Parking Places) Consolidation and Variation Order 2011 to provide parking spaces at specific times along the lengths of road specified in the Schedule below. This scheme was originally advertised on 10<sup>th</sup> July 2020 but due to an administrative error an Order was not made and it is necessary for it to be advertised.
