### Terms and conditions for Holt Country Park Photo Competition

#### **The Competition**

Organised and solely run by North Norfolk District Council to select the best digital images for the Holt Country Park Photography Competition.

# **Competition opening and closing dates**

Competition opens: 1<sup>st</sup> September 2018
Competition closes: 31<sup>st</sup> August 2019

# 1. <u>Conditions of entry</u>

- **1.1.** This competition is free to enter. Any expenses incurred in the process of entering the competition will not be reimbursed.
- **1.2.** This competition is open to everyone except North Norfolk District Council employees and Councillors. All information detailing how to enter this competition forms part of the terms and conditions.
- **1.3.** The decision of the judges is final and no correspondence will be entered into with respect to how the decision was made.
- **1.4.** All photos submitted must have been taken in the month immediately preceding submission.
- **1.5.** There is no limit to the number of images each entrant may submit.
- **1.6.** In order for the submission to be valid, the subject of the photo must be of Holt Country Park.
- 1.7. All entries submitted must be the original work of the individual submitting them. Entries must not be copied, must not contain any third-party materials and/or content that the entrant does not have permission to use or have any watermark or signature added. If North Norfolk District Council has reason to believe any entry is not the entrant's own work or otherwise breaches this rule, the entry will NOT be considered.

# 2. Image specification

2.1. Entries must be min 300dpi. Still images only and minor detail adjustments are permitted.

## 3. Copyright

**3.1.** Copyright of all entries remains with the entrant, but North Norfolk District Council, Partners and 3<sup>rd</sup> Party Organisations reserve the right (but shall be under no binding obligation) to use, Publish and republish all entries in connection with the competition (as set out in 4.5 below),

and in promoting Holt Country Park without remuneration. By entering this competition, the entrant grants irrevocable permission to North Norfolk District Council to reproduce any submitted photos on web sites, social media and printed material should they be selected to promote the competition and Holt Country Park, as well as the district of North Norfolk.

**3.2.** Photos must not be in the opinion of North Norfolk District Council, obscene, defamatory, offensive or in breach of any applicable legislation or regulations.

## 4. Data Protection

- **4.2.** Entrants confirm by submitting an entry that any individual whose image is clearly identifiable in the competition entry has given consent for the use of his / her image in connection with this competition and in accordance with these terms and conditions and publicity detailed in condition 3.1 above.
- **4.3.** Where an individual whose image is clearly identifiable in a competition entry is less than 16 years of age, the entrant must confirm that the parent or guardian of that individual has given the relevant consents.
- **4.4.** Entrants confirm that by entering, they will provide evidence of completed consent forms upon request to North Norfolk District Council, who will contact the entrant where applicable.
- **4.5.** North Norfolk District Council will only use entrant's details to contact them about their competition entry.

## 5. Prizes

**5.1.** Each of the twelve winning entries will receive a prize which has been supplied by local businesses. These vary and will be confirmed on a monthly basis.

# 6. Selecting a winner

- **6.1.** Throughout the duration of the competition, a panel of judges will select that month's winner and will notify the winner using the contact information provided by the entrant upon entry and in accordance with clause 4 above.
- **6.2.** As the organiser of the competition, it is the responsibility of North Norfolk District Council to select the winners and conduct the competition in a fair and non-discriminatory manner. Entries will be made anonymous for the judging process.

# 7. Publicity of the competition

**7.1.** The winner's names and entries will be published on digital media and printed communications.

#### 8. Indemnity

**8.1.** The entrant shall indemnify North Norfolk District Council against all cost and losses suffered by it caused directly or indirectly by any breach of these rules.

# 9. Good faith

**9.1.** North Norfolk District Council and entrants will participate in the competition in good faith at all times.
